The meeting began at approximately 9:00AM, initiated by Dr. Robert Jaffe (ConSysTec) who gave an overview of the training sessions held in April. Manny Insignares, task leader for the ITS architecture development, continued with the Traffic Management presentation.

- Stakeholder Comment: Is there any direct link regarding weather conditions from Transportation Operation Coordination Committee (TRANSCOM) to any other agency?
- Mr. Insignares: TRANSCOM Communication Center Servers are shown as future clearinghouses for road weather information.
- Stakeholder comment: DRJTBC presently communicates with numerous agencies via phone. In the future this operation will be carried through the traffic center.
- Mr. Insignares: With whom will DRJTBC share information? Stakeholder comment: It would share information with NJDOT Traffic Operation Center North (NJDOT TOC North) and NJDOT TOC Central (planned), Pennsylvania DOT district 4, 5 and 6 and the Traffic Management Associations (TMA).
- Stakeholder comment: The PANYNJ facilities are decentralized and communication is conducted through TRANSCOM.

Mr. Insignares explained that the project documents, inventories and customized market packages for the workshop will be posted in the next few weeks and asked for the stakeholder's active participation and to review their systems and its representation in the architecture.
