1. Introduction

1.1. Background

On August 18, 2008, the Mid-Ohio Regional Planning Commission (MORPC) advertised a Request for Letters of Interest for interested firms to submit a letter of interest to provide professional services to assist with certain aspects related to updating the Regional ITS Architecture.

In response to this Request for Letters of Interest, a team of HNTB and Consensus Systems Technologies (ConSysTec) responded with a proposed Scope of Work on October 1, 2008. On October 29, 2008, HNTB received a Notice To Proceed.

Task 1 of the Scope of Work was to review the existing MORPC Turbo Architecture database and create a list of suggested changes or improvements to the database. The suggested changes were to be documented, sent to MORPC, and reviewed. This Technical Memorandum satisfies the documentation portion of Task 1.

Only the Stakeholder Inventory and the ITS Elements Inventory were analyzed and reviewed for Task 1. Other portions of the MORPC Turbo Architecture database, such as the Services, were analyzed and reviewed in other tasks.

1.2. Document Organization

This Technical Memorandum is organized in three sections.

- Section 1: Introduction. This section provides background information about and the purpose of this technical memorandum.
- Section 2: Analysis. This section provides an analysis of the existing Turbo Architecture database, summarizes the proposed changes and the reasons behind the suggested changes.
- Section 3: Proposed Changes. This section lists the changes made to the Turbo Architecture database.

2. Analysis

A quick analysis of the MORPC Turbo Architecture database Version 10, dated February 26, 2008, yielded the following results:

- 160 Stakeholders
- 216 ITS Elements

The following lists the number of elements mapped to each subsystem:

- Archived Data Management Subsystem: 21
- Commercial Vehicle Administration: 1
- Emergency Management: 24
- Information Service Provider: 12

- Maintenance and Construction Management: 17
- Parking Management: 4
- Remote Traveler Support: 7
- Roadway Subsystem: 68
- Security Monitoring Subsystem: 10
- Traffic Management: 14
- Transit Management: 7

2.1. Stakeholders




Figure 1. MORPC Transportation Planning Area

The MORPC Regional ITS Architecture database currently contains 160 stakeholders. These stakeholders represents the various counties, cities, townships and villages in addition to other state government agencies and private entities that has a role in transportation within the MORPC transportation planning area. This transportation planning area includes Franklin and Delaware Counties, as well as parts of Licking and Fairfield counties, as shown in Figure 1.

For local counties and municipalities, the stakeholder inventory lists each government department and agency as a separate stakeholder, such as a city police department, fire district, or engineer's office.

While listing each department and agency may be more complete, there is little additional benefit to a regional ITS architecture of being so thorough and it makes the maintenance of the stakeholder inventory difficult and unwieldy. The existing stakeholder inventory can be considered relatively large and repetitive; and even minor changes to a stakeholder name or definition may require an update to the Turbo Architecture database.

Thus, it is recommended that some of stakeholder inventory be consolidated as follows:

Single Municipalities or Counties

Create a single stakeholder that would represent all departments for that municipality or county. For example, instead of having a single City A Police Department, City A Fire Department, and City A Public Works Department, there would be a single City A stakeholder that would represent all the departments for City A. This approach eliminates the need to update the Turbo Architecture database as departments are renamed or if functions are moved to different departments, while also decreasing the size of the stakeholder inventory.

For municipalities or counties who play a major role in the transportation services in the region, such as the City of Columbus, Franklin County, or the State of Ohio, each department or agency remain listed as a separate stakeholder because of their role at a regional level in providing transportation services. Thus, clarity in which government department is responsible for that function has utility in the regional ITS architecture.

Generic Stakeholders

Add several generic stakeholders to the Stakeholder inventory. A region will have a stakeholder that does participate in the transportation services provided in a region, but has a small role. Or as a region grows, either in population or development, new stakeholders will appear that may not have existed at the time the MORPC Turbo Architecture database was last updated.

Thus, the creation of several generic stakeholders is recommended. Generic stakeholders might include Local Fire Departments, Local Maintenance and Construction Providers, Local Police Departments, and Private Traveler Information Providers. These generic stakeholders would include any other existing stakeholder not specifically called out in the Stakeholder Inventory and any other future stakeholder.

2.2. Elements

The MORPC Regional ITS Architecture database currently contains 216 ITS elements. These ITS elements represents the various systems, devices and other ITS entities that perform a function related to transportation within the MORPC transportation planning area.

The name of each ITS element generally followed the convention of the type of system, followed by the "owner" of the ITS element, e.g., CCTV – ODOT. The "owner" generally describes the stakeholder that paid for the element, operates it, maintains it, or all of the above. By naming ITS

elements in this manner, it may make searching for all the systems owned by a stakeholder more time-consuming. When searching through a regional ITS architecture, users are generally more interested in seeing what elements are "owned" by a stakeholder than by type of system.

Some of the ITS elements represents a very specific ITS system or device, or is a subsystem of a "larger" ITS element. For example, Automated Passenger County – COTA, Automated Voice Announcer (AVA) – COTA, and Vehicle Component Monitoring – COTA are all systems within the Transit Fixed Route Vehicles – COTA ITS element.

ITS elements may also exist for every stakeholder that has that type of system or device. For example, there are 28 ITS elements that represent traffic signals owned by a municipality or other stakeholder. While correct, having 28 ITS elements just representing traffic signals becomes a little unwieldy to maintain.

Thus, it is recommended that some of ITS Element inventory be changed as follows:

Rename Elements

Rename the elements so that the stakeholder "owner" is named first. For example, CCTV – ODOT would be renamed ODOT CCTV.

Generic Elements

Create generic ITS elements that represent multiple instances of a system or device. For example, consolidate the smaller traffic signal systems and devices into a single generic traffic signal system called Local Traffic Signals. This single generic ITS element represents all the traffic signal devices in the region operated by local governments not specifically called out in the MORPC Regional ITS Architecture. Thus Local Traffic Signals would not include ODOT Traffic Signals nor City of Columbus Traffic Signals because of the larger roles both agencies play in the region. Nor would Local Traffic Signals include CRAA Traffic Signals or OSU TPS Traffic Signals because neither are local governments (municipalities).

Using generic elements also has the additional benefit of consistency. Because Local Traffic Signals represents multiple local governments, each local government using the regional ITS architecture to design or procure their traffic signals may implement their traffic signals in the same way, possibly resulting in interoperability. For example, two different local governments looking to implement a vehicle pre-emption capability may both look at the regional ITS architecture, realize that the whole region should implement the vehicle pre-emption in the same manner, then work together to implement the capability similarly or simultaneously.

2.3. Other Changes

In addition to the changes outlined above, several other changes are suggested to the Stakeholder Inventory and the ITS Element Inventory. Several stakeholders and elements were added to the inventory to support the transportation services defined in the customized market package diagrams created in Task 2. Also, the mapping of all ITS Elements to Subsystems and Terminators was checked and where the mapping appeared incorrect or was unnecessary, those mappings were changed.

3. Proposed Changes

After making the above proposed changes to the MORPC Turbo Architecture database, and after completing Task 2, Prepare Customized Market Package Diagrams, an analysis of the MORPC Turbo Architecture database, yielded the following results:

- 120 Stakeholders
- 123 ITS Elements

The following lists the number of elements mapped to each subsystem:

- Archived Data Management Subsystem: 9
- Commercial Vehicle Administration: 2
- Emergency Management: 19
- Information Service Provider: 13
- Maintenance and Construction Management: 6
- Parking Management: 3
- Remote Traveler Support: 4
- Roadway Subsystem: 22
- Security Monitoring Subsystem: 4
- Traffic Management: 9
- Transit Management: 6
